

Silverton Marching Band Uniform Loan Contract

ALL MARCHING BAND UNIFORMS: are to be considered the property of Silverton High School Band and have been purchased for the exclusive usage of the instrumental music students (Grades 9 through 12), participating in the Silverton High School Marching Band.

ALL MARCHING BAND UNIFORMS are an expenditure to the community that totals an amount of approximately \$32,000.00. We expect that these uniforms be used by students involved with the instrumental music program for at least 15 school years. It is for this reason that uniforms on loan to our instrumental music students must be properly used and maintained.

Below are the expectations, conditions and requirements for accepting the loan of a marching band uniform on behalf of a student. This loan contract agreement must be signed by the **parent or legal guardian** of the participating student accepting full financial responsibility for the protection, care and return of the uniform. It is the responsibility of the students and parents and/or guardians to return the loaned SMB uniform in the identical condition in which the uniform was originally issued after each performance.

Below is a table explaining the cost of each component of the uniform so that you may be aware of the monetary value of each SMB uniform for which you will be accepting responsibility.

Additional Components to the Marching Band Uniform

(NOT covered or supplied by the Silverton high School Band):

- All SMB students are responsible for obtaining their own **BLACK** shoes and **BLACK** socks.
- Students without **Black Shoes** and **Black Socks** will not be permitted to march in performance.

Distribution

- Students will be issued a complete uniform on or before the final day of Band Camp in August of the approaching school year.
- Each uniform has been numbered and tagged to insure that each student is returning the same uniform that was issued in August.
- Each student and parent/guardian will accept full responsibility for the issued uniform throughout the course of the year.
- Damages, tears, stains, holes or other indications of abuse or neglect must be **PROFESSIONALLY REPAIRED BEFORE** the uniform is to be returned.

Usage

Students will be expected to wear the Marching Band Uniform at the following events:

- All Home Football Games.
- All Community Parades.
- All Marching Band Performances.
- Any Marching Band festivals or competitions in which the Marching Band may participate.

Maintenance

- In the event of an accidental spill or other damage, it is the responsibility of each student to **DRY CLEAN** the uniform **BEFORE** the next scheduled performance.
- All Marching Band Students are expected to protect and care for their own uniforms. **DO NOT TRADE, LOAN** or otherwise **GIVE AWAY** any component of the uniform for which **YOU** have accepted responsibility.
- You will be held **FINANCIALLY RESPONSIBLE** for the uniform you were issued!

Repairs and Service

Students are responsible for all repairs and service from normal wear and tear to excessive abuse.

Loss or Damage

Students who damage a uniform beyond repair or lose any or all components of the uniform will be expected to replace the components of the uniform that are lost or beyond repair.

PLEASE SIGN AND RETURN

I UNDERSTAND and ACCEPT that **I am accepting full responsibility** for the Marching Band Uniform that is being loaned by the Silverton High Marching Band.

I UNDERSTAND and ACCEPT that the uniform will be returned to the SMB in the original condition after every performance

I UNDERSTAND and ACCEPT that I must provide **Black Shoes and Black Socks** that are not a part of the issued band uniform.

I UNDERSTAND and ACCEPT that ALL components of the uniform are to be **returned together and at the same time.**

I UNDERSTAND and ACCEPT all of the rules and expectations set forth in the uniform information.

I UNDERSTAND and ACCEPT a dry cleaning fee of \$15 will be assessed at the end of the school year.

I UNDERSTAND and ACCEPT that this form **MUST** be completed, signed and **RETURNED** to SHS Band **BEFORE** the student named below will be issued a uniform.
